





2nd EU Consortium on Non-Communicable Diseases Prevention (EU-CNCD Prevention¹) Meeting

Scope and Purpose

The Joint Action Prevent Non-Communicable Diseases is designed to address the challenge of the persistently high rates of cancer and other non-communicable diseases (NCDs) in EU by supporting strategies and policies, focusing on both personal and societal risk factors. The project's major goal is to minimize fragmentation and duplication of efforts and to engage national authorities at various levels to enhance the impact of actions taken. A significant aspect is the rigorous consideration of these actions to assist authorities in prioritizing the most effective disease prevention / health promotion strategies and exploration of the means of their implementation. Those joint efforts of the vast majority of EU MSs should contribute to achieving national, EU and global targets in reducing the NCD burden at individual and societal levels.

To achieve its goals and the sustainability aims, the JA PreventNCD is mandated to develop and support the establishment of the multi-layer European Consortium on Non-Communicable Diseases which should continue with its functions after the Joint Action ends in December 2027.

Building on the results of discussions from the 1st EU-CCP/ EU-CNCD Prevention meeting which took place in Brussels, Belgium, on 11 September 2024², the 2nd EU-CNCD Prevention meeting will be held in-person in Katowice, Poland between 17 and 18 June 2025.

The second meeting will serve as a deep dive into the scope and responsibilities of the EU-CNCD Prevention from the perspective of long-term vision, purpose, aims and organization. Special attention will be dedicated to equity and wellbeing perspectives. The zero-draft concept of the body's functions and operations will be presented for further discussion by the participants. Special focus is given to the engagement of the organised youth representatives, to allow for youth perspectives in the discussion on policy and actions development, especially in the present combined traditional and digital realities.

Cordially invited to the event, we are excited to learn from your experience and expertise on how to best foresee the new NCD body at the EU level to assure its effective and useful long-term public health driven function.
